The meeting was called to order at 6:00 p.m. by Mayor Pro-Tem Martinez.

#### APPROVAL OF AGENDA

A motion to approve the agenda was made by Trustee Barela, seconded by Trustee Gallegos. Roll Call-All in favor. Motion Carries.

#### CITIZEN COMMENTS

Deacon Jerry Leblanc – Deacon Leblanc commended the Town of Center, the Utility crew and Street Crew. Deacon Leblanc said that on July 21<sup>st</sup> and one other date that the Utility and Street Crew went the extra mile. They are kind, polite and top notch workers.

#### CONSENT AGENDA

Minutes – No questions were asked.

Court Report – The model Traffic code was used a mobile handicapped ticket. Abated be refunded. Attorney Trujillo said that it can still go under the 42 code. Natalia said that she did advise the defendant to come to court to let the Judge dismiss it. Trustee McClure would like fine amounts on the report.

Police Report – There were fifteen more tickets than the month prior. The cases have kept the department busy. Assist on County Rd. GG was an agency assist. Chief Fresquez said he would look into it an email the Board with an answer.

Public Works Report – Jaime said that the guys have been working beyond his expectations. They have been having meetings with Attorneys and different agencies. Jaime has started working with Rio Grande County and they are spraying the goat heads at the Park. They sprayed 5.5 acres. Jaime will look into grants for noxious weed.

Utilities – Sensus did come and work on our hand held meters. They were old commercial meters that weren't coming in on the system. The Generator has been fixed. The relay switch

went bad. Eighty-seven disconnects were sent out, six were disconnected. Trustee McClure said that as a board that they should contact the PUC that the cost for the pathway project should be adjusted. Jaime will talk with Mike on how to write this letter.

Water- Jaime would like to talk with the Sanitation District about some issues that are of concern. The back flow is at about 82-85 % completed. Trustee McClure would like a consumption usage report monthly.

Streets and Parks – This department is the one that is busy doing different things.

Building Report – Sergio has been busy, 15 permits were applied for. People are complying to their violation. There were some concerns about the elderly.

#### **PAYABLES**

Trustee McClure asked if we had a policy on receiving compensation for a Board Member. The Town is paying the accountant mileage and lodging. Brian said that it is not out of the ordinary, we paid Ruben Brown. Brian will research if it is out of the ordinary. A motion to approve the payables was made by Trustee Barela, seconded by Trustee Gonzales. Roll Call—Trustee Beiriger, Trustee Gallegos, Mayor Pro-Tem Martinez, Trustee Gonzales and Trustee Barela - Y. Trustee McClure — y to all bills with the exception of Paula Martinez which he Voted-N. Motion Carries.

#### MANAGERS REPORT

Brian received an email from the attorneys about the complaint to FERQ on the pathway project. Brian will contact the attorney about the monies received by Xcel. The Town received the \$20,000 check from CHAFA for the murals.

#### **NEW BUSINESS**

Presentation of Plaque – Robert Gonzales – Brian presented Rob with the Plaque for his years of service to the Town. The Plaque said Streets and Parks but Robert worked in the Water Department also.

Renew Liquor License - M&M Liquor – A motion to approve the renewal of the Liquor License was made by Trustee Gallegos, seconded by Trustee Gonzales. Roll Call – All in favor.

Review for Financial Policy Committee — Trustee McClure says that the committee would be strictly the Board members. Trustee McClure would like a policy to invest the monies. Trustee McClure would like policies and guidelines, if not a committee then at least workshops. Paula is getting clarification as to what Wall, Smith and Bateman felt about transferring monies and how often.

Citizen Comments – Response – Bryam Ornelas – Bryam came before the Board at the last meeting. Brian said that they Town is not picking on him, he is in a residential area. Some of the pics that he brought in are in blight area. Brian would like Bryam to have a timeline to apply for a variance. The application has to be submitted prior to the planning commission. There is a conveyance in that subdivision (rules and regulations) those need to be followed. Attorney Trujillo asked that he get a copy of the subdivision and the conveyance. The landowner has to apply for the variance. Bryam asked how would you define trash or building materials? It's considered inventory. Mayor Pro-Tem Martinez said that the Board will wait until he has the conveyance. A motion to table this issue until there is verification of the convenance was made by Trustee McClure, seconded by Trustee Beiriger. Roll Call – All in favor. Motion Carries.

#### **OLD BUSINESS**

Review Utility Reserve Policy – Brian said that there are somewhat of a reserve already. Trustee McClure said that there is a dollar amount that needs to be in reserves. A workshop is needed to discuss this. Trustee McClure felt that we are in a time constraint since we are in the Budget talks.

# Town of Center Public Works Department.

#### **Public Works Directors Report**

Since September 12<sup>th</sup>, 2023, the public works and all departments within have been busy preparing for the winter season among other daily projects and follow-ups that each department had in their daily duties. (see below).

During these several past weeks, there were a lot of follow-ups with all the departments about some of their daily duties and projects that are happening. Also, as you all know we are in budget season and this takes a while preparing budget for next year. Brian and I did a follow up on a mini-grants and that the Town of Center received this year and this grant must be completed by December.

Rose brought to my attention that she has found some accounts on Caselle, that for unknown reasons meters dropped out, or are not reading in the system at all, therefore those accounts have not been getting charged correctly or haven't been charged at all. We have been backtracking and looking into this more in-depth and we are going to do our best to make sure that every account is correct from this day forward. Also, I have been on the phone with Sensus constantly this past couple of weeks, trying to figure out why some of these meters are showing "o" reads or no reads at all. They are recommending software upgrade.

I know that there are some questions and/or concerns among the citizens of Center, about some of the street lights being out of service, I can assure you that I am very aware of it and I do have a list in my office of those street light that needs to be replaced. I am only waiting for next year's budget to get approved so that we can order some and get those lights replaced and working properly. As you all know and probably noticed, all stop signs are put in place on Fullenwider St., Sisneros and 5<sup>th</sup> St. Also, our Christmas ornaments down Main St. were set this past week.

I am working on setting up some cameras at N90 and Community Park. I have been working with Julio about the possibility of being able to connect to a WiFi service for the cameras to work. I believe that having this installed at the parks, will eliminate some of the problems that we are experiencing and also, be able to have the N90 open to the public during the weekends, so the community is able to go and dispose of any trees, limbs, branches, etc. without the worry of having someone there all the time making sure they do not throw trash or other items that are not permitted.

Last but not least... and what everyone is waiting to hear. Utilities; I have been paying very close attention to all utility prices, but especially gas. Looking at past records, the last time there were price increases on electricity, was May 2023, and before that – there was not change for the whole 2022 year. On the water, there has not been an increase since 2002 (that I could tell). On gas, we had an increase just this past August. On a daily basis, as soon as I get to my office at 7 a.m., the first thing I do is check natural gas prices and keep a record of it on

my calendar. Just in the month of October, there was a 25.88% price increase which is about .74 cents. Although, I am trying my best to keep prices of gas (and all utilities) at a low cost for the community as much as possible, please understand that it is also my job and responsibility to make sure the Town of Center doesn't lose while purchasing those services. Therefore, I just want to make you and the community are aware that there will be some increases in prices coming up in the next couple of months.

- o 31 Contractor and business Licenses have been issued YTD, for a total of 110.
- o Follow-ups with ordinance violations and permits.

- Working on the audit of operator manuals.
- o Operator qualifications and Public Awareness.
- o Converted 15 overhead residential services between 2<sup>nd</sup> 4<sup>th</sup> St. and Wills to Miles St.
- o Replace the Transfer switch for the generator at Town Hall.
- o Repaired water hydrant knocked over by a car at the corner of 1st and Broadway.
- o Searching for water pits at 410 Miles, 647 Miles, and 745 Broadway.
- o Installed Christmas Ornaments on Main St.

#### Water and Sanitation

- TTHMs, HAA5s, and the VOCs samples were collected and sent for testing our Drinking water is safe.
- Water tank inspection was completed for this month. The water tank is in good condition, but we are waiting for the documentation from them about the overall status of the tank.
- Back flow compliance and commercial water meter continue to be an ongoing project.

#### Streets and Parks

- o Blew up all sprinkler systems at the parks and Casa Blanca restrooms.
- o Cleaned the Town Shop in/out.
- Added dirt on 1<sup>st</sup>. St. to cover put holes.

# WATER AND SANITATION DEPARTMENT OCTOBER 2023 REPORT

11/1/2023

#### WATER OVERVIEW

#### 1. Drinking Water Monitoring Schedule

We are continuing this year's monitoring schedule and results are still meeting requirements. We collected the TTHMs, HAA5s, and the VOCs samples. Our drinking water is great.

#### 2. Chlorine Residual

The residual chlorine continues to be consistent throughout the distribution system with some variation at entry point. We order 4 new barrels of chlorine mid-week. We changed the Cl2 barrel at the West and East Well.

#### 3. Water Quality

We conducted water quality assurance calls to customers as directed and we did water turn on and offs as needed.

#### 4. Projects

We are getting close to being back in compliance with the backflow surveys and testing. We are still working on getting all of the commercial water meters to read automatically. We are still waiting for a new meter register for the preschool from Sensus. We are waiting on MXU from set flow that is under warranty. We have really pushed and been successful in getting our commercial customers to install meters and backflow devices. We did meter reads and testing at the end of the month. We are working with Tim to get some of the sensus meter to try and read from the computer. We installed MXU in Casa De Cortes apartment buildings to try a get them ready. We have been in touch with sensus about a new program that's going to help us salve the issue with our meters. Sensus is trying to get us some support with the computer side of thing. We are working on ordering some more backflow and more meters.

#### 5. Water Tank

We have completed the Water Tank inspection for the month. The Water Tank is in good condition. We should be getting documentation from them about the overall status of the tank soon.

#### 6. Other Tasks

Backflow compliance and commercial water meters continue to be ongoing projects. Our fire hydrant flushing program has been underway. Gate valve exercising will be started soon. We are working on getting an inventory of the different size lids for the manholes. We are working with sensus to get a update for the commercial meters to get them to read.

#### SANITATION OVERVIEW

#### 1. Process Control Monitoring

We continue to run daily process control tests. There's nothing to report as all the numbers have been good.

#### 2. Lift Station Checks

Daily lift station checks have been completed. We have had a few issue with floats going bad. Grease continues to be a problem that we are working on addressing. We are creating an informational pamphlet on what not to flush including grease.

#### 3. Sewer Obstructions

We have had only a few calls this last month on sewer issues and backups. We continue to address the calls as the come up.

#### 4. Jetter Truck

We are waiting to hear back from the County Commissioners about the remaining cost, in the meantime the Vactor is being built and could be a 12 month lead time.

#### 5. Sampling and DMR's

All sampling and lab work continue to be completed with no issues. All of our labs and DMRs have been compliant.

#### 6. Plant Operations

We are working nonstop on the up keep and preventative maintenance for the plant. We are working with technicians and representatives on the calibrations for our effluent meter as well as communications errors with a pump. The service technician for the pump communication failure came out and determined that the pump head is still good but the compact logic has gone bad. They are shipping a new one to us and it is under warranty. We have been in the process of starting up the second train in the wastewater treatment plant.

#### 7. Other Tasks

We continue to work with the Board to update policies. We have a company coming soon to inspect the collection system. We are working on updating the sewer layer in Diamond Maps so the company can utilize it for their project, this includes finding and confirming manholes in the system. The construction for our office should start soon. We have been spending a lot of time on reworking the policies and gather data especially for the commercial "BOD" customers.

# A RESOLUTION OF THE TOWN BOARD OF TRUSTEES AMENDING RESOLUTION 20221206-A CONCERNING TRANSFER OF FUNDS FROM LIGHT AND POWER FUND TO THE WATER FUND.

WHEREAS, the Water Fund was short in its budget for 2021 by \$125,000.00 and;

WHEREAS, the Light and Power Fund Loaned the Water Fund \$125,000.00 to be paid back within one year and;

WHEREAS, the Water Fund did not receive the revenues as projected to pay back the Light and Power Fund within one year and;

WHEREAS, the Light and Power Fund is prepared and capable of extending said Loan to the Water Fund of \$125,000.00 for and additional one year.

# NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE TOWN OF CENTER, COLORADO AS FOLLOWS:

Section One. The Town Trustees authorize the extension of the loan from the Light and Power Fund to the Water fund for an additional year and to continue to extend every subsequent year until such time the Water Fund Revenues are at a level to pay back such loan, or until the Board of Trustee's deem it necessary to forgive such loan. This loan was to cover the Water Funds shortfall in 2021 budget year. This said loan was to be paid back within the extended year 2023. The loan shall incur a .50 interest per annum. in lieu of taxes. The following percentage of sales generated by each fund shall be transferred to the general fund each month to begin on January 1, 2024 and shall continue until said loan is paid in full or forgiven by the Town Board of Trustees.
